Welcome, it's so nice to see all of you here. Your presence and input are so vital in ensuring a smooth running corporation and the best Mutual in Seal Beach Leisure World.

I want to begin by thanking all of the Foundation staff, especially my friends in the Accounting Office, for all their help and assistance. They have taught me so much about finances.

This is the Annual Report and all of you have been provided with an audited review of the year ending December 31, 2016. Thus, you know that Mutual 8's Total Stockholders' Equity is \$4,222,099. The Mutual ended the 2015 year with net worth of \$3,975,243. For 2016, there were some operating costs over budget and others under; in the whole, the budget functioned as it should as a operating guideline. It was a good year. An update for 2017 will be discussed at the June meeting.

The investment experts at BNY Mellon, reported that during 2016, the Mutual bought 7 Municipal Bonds and sold 7 Bonds for an audited income of \$41,530.00. As you know, our policy with municipal Bonds is to replace matured bonds with new ones. All have AA ratings or better and have interest rates of 4 to 5%.

Mutual Reserve funds amount to \$2,098,588. While the Mutual has practiced preventative maintenance for the physical property, there will shortly be some major needs, hopefully in the tiered process that was planned.

This report is positive. Soon we will begin the budgeting process for 2018. Please consider letting me know, either by email or at the next meeting your thoughts about the upcoming budget. Your input is appreciated. Thank you once again. God bless you; God bless Mutual 8; God bless America.
